### TICKET PRICING:

1. CRPA charges **\$24.25** for each ticket code requested.
2. Towns may upcharge tickets for sale to their residents. When deciding on a sale price, keep in mind your cost vs. the Lake Compounce gate prices: Adults \$51.99; Kids \$41.99 *\*plus tax and processing fees*

### TOWN CARAVAN RESERVATION PROCESS:

1. Reserve a date (**MONDAY - FRIDAY ONLY**) with CRPA for your residents to enjoy a safe outdoor adventure at Lake Compounce.
2. Get the word out and sell some tickets! Your residents will enjoy the **best rates**, added **safety of traveling in their own vehicles**, all the **fresh air** they can inhale, and tons of **theme park fun**.
3. Please collect the name of each individual that signs up and the email address they would like their ticket codes sent to (for example, if 5 people in the Smith family are joining the caravan, you would need to collect all 5 names and the email address the ticket codes can be sent to)
4. Registrations for the Town Caravan **MUST STOP** 5 days before the event.
5. 5 days before your Town Caravan, provide CRPA with a roster of attendees.
  - CRPA will send you an excel file of the roster template that you need to complete.
  - We recommend requiring your residents to **PRE-PAY** before adding them to your roster.
  - Once the roster is submitted to Lake Compounce, **YOU (the town)** are responsible for payment for those tickets.

### THE PARKS AND RECREATION AGENCY AGREES TO:

1. **Use tickets for a caravan trip on a specific day and keep written records of registrants.**
2. Pay in advance with each caravan order or pay within two weeks of each caravan trip.
3. Adhere to all policies and rules which Lake Compounce has promulgated for safe operation of the Park. No person shall bring alcoholic beverages into the Park. No outside catering service or bulk food and beverage may be brought into/delivered to the Park.

### CRPA AGREES TO:

1. Book caravan order with Lake Compounce at our discounted rates, which are not available to the public.
2. Provide telephone/email support to assist with your order and planning needs.

### IMPORTANT INFORMATION:

- Masks are required to be worn at all times indoors and out, with social distancing.
- Caravan trips may be booked before September 3, 2021. Please check the schedule on Lake Compounce's website before booking your trip to confirm they will be open on the dates/times you request for your trip(s). To avoid disappointment due to an unusual situation, towns are urged to call ahead to confirm days and hours for your visit.
- **No refunds will be given once rosters have been submitted to Lake Compounce.**
- Parking is an **ADDITIONAL FEE** payable directly to the Park.
- Dining is available onsite.
