## CHANGES DUE TO COVID-19:

In order to better protect the health and safety of our members and their residents, CRPA and Lake Compounce have adopted a touch-free method of ticket purchasing and redemption. **No physical tickets will be issued for Lake Compounce this season.** Instead, ticket codes will be emailed to towns participating in the Consignment Ticket Program. These codes may be sold to the general public which they can redeem through the Lake Compounce's website for a specific time and date. Pre-registration will be required for anyone visiting the park.

### Ticket Order Quantities:

1. Towns/Departments who are new to this program can start off with a 25 ticket code starter packet.
2. Towns that are returning for the 2021 season: ticket code request cannot exceed 25 tickets **more** than sold in the previous year. Contact the CRPA office for your previous year total at (860) 721-0384.

*\*When you are down to your final 5 ticket codes we will gladly send you another 25 codes.*

### The Parks and Recreation Agency agrees to:

1. **Return a list of all unused ticket codes by September 3, 2021 or accept full responsibility for payment of unused codes.**
2. Sell ticket codes only as part of a parks and recreation program, keeping written records.
3. **Ticket codes cannot be refunded once redeemed online through Lake Compounce's website.**
4. Adhere to all policies and rules which Lake Compounce has promulgated for safe operation of the Park. Some rides are restricted by height and size. No person shall bring alcoholic beverages into the Park. No outside catering service or bulk food and beverage may be brought into the Park. No picnic baskets or coolers will be permitted inside the Park.
5. Be responsible for the accuracy of the ticket numbers and quantity delivered to you. Any discrepancies must be reported to CRPA upon receipt of your ticket codes. If nothing is communicated to CRPA, our office will assume that the order was accurate and the details on this form match the ticket codes delivered. CRPA cannot be held responsible for lost or missing, or wrongly-issued ticket codes if discrepancies are not reported to us within 24 hours of receiving the ticket codes.

### CRPA will provide:

1. Promotional materials, including posters and background information on Lake Compounce.
2. Ticket code delivery in a timely manner.
3. Telephone support to assist with your orders and planning needs.

## Important Information & Notices

1. Ticket sales may begin as soon as you receive ticket codes. A list of unsold ticket codes must be returned to CRPA by September 3, 2021. THIS IS A FIRM DATE. No lists of unsold tickets will be accepted after that date, and no refunds will be issued for any ticket codes returned after that date. **All tickets must be PAID IN FULL by September 3, 2021.**
2. Although these ticket codes apply to all normal days and hours of operation for Lake Compounce, to avoid disappointment due to weather or an unusual situation, you and your customers are urged to call ahead to confirm days and hours for your visit. No refunds will be given once ticket codes have been redeemed. Unused ticket codes must be returned to CRPA no later than September 3, 2021, for a refund.
3. Please encourage all individuals purchasing tickets to check the schedule on Lake Compounce's website to confirm they are open the dates/times they wish to visit the park.
4. Children age 3 and under are free.
5. Parking: \$10.00 per vehicle. *Parking fee is subject to change. Fee is payable to Lake Compounce on the day of your visit.*
