



# NEW FOR 2021: Town Caravan to Six Flags!

**PRE-REGISTRATION IS REQUIRED FOR TOWN CARAVAN TICKET ORDERS.**

**I WILL PROVIDE CRPA WITH A COMPLETE ATTENDEE ROSTER AT LEAST ONE BUSINESS DAY BEFORE TOWN CARAVAN. THERE ARE NO REFUNDS OR DATE SUBSTITUTIONS FOR TOWN CARAVANS.**

**TICKET PRICING:**

1. CRPA charges **\$31.99** for each ticket requested.
2. Towns may upcharge tickets up to \$2.00 for sale to their residents.

**TOWN CARAVAN RESERVATION PROCESS:**

1. Reserve a date (**MONDAY - FRIDAY ONLY**) with CRPA for your residents to enjoy a safe outdoor adventure at Six Flags.
2. Get the word out and sell some tickets! Your residents will enjoy the **best rates**, added **safety of traveling in their own vehicles**, all the **fresh air** they can inhale, and tons of **theme park fun**.
3. Registrations for the Town Caravan **MUST STOP 5 business days** before the event.
4. **5 business days** before your Town Caravan, provide CRPA with a roster of attendees.
  - CRPA will send you an excel template to be completed which must include the name of the person picking up tickets at will-call **AND** the total number of tickets purchased per family.
  - Template can also be found online [HERE](#).
  - *We recommend requiring your residents to **PRE-PAY** before adding them to your roster.*
  - *Once the roster is submitted to Six Flags, YOU (the town) are responsible for payment for those tickets.*

**THE PARKS AND RECREATION AGENCY AGREES TO:**

1. **Use tickets for a caravan trip on a specific day and keep written records of registrants.**
2. Pay in advance with each caravan order or pay within two weeks of each caravan trip.
3. Adhere to all policies and rules which Six Flags has promulgated for safe operation of the Park. No person shall bring alcoholic beverages into the park. No outside catering service or bulk food and beverage may be brought into/delivered to the park.

**CRPA AGREES TO:**

1. Book caravan order with Six Flags at our discounted rates, which are not available to the public.
2. Provide telephone/email support to assist with your order and planning needs.

**IMPORTANT INFORMATION:**

- **Masks are optional, but encouraged, for unvaccinated visitors**
- Cash is not accepted at the park. Only cards and mobile payments are accepted at all locations in the park including restaurants, retail stores, and games. Cash can be converted to a prepaid Visa debit card at one of the kiosks located through the park for no additional fee. Any remaining funds on the card can be used outside the park anywhere Visa cards are accepted.
- Caravan participants **MUST SHOW A PHOTO ID** in order to pick up tickets. **TICKETS WILL ONLY BE RELEASED TO THE INDIVIDUAL LISTED AS THE PICK-UP PERSON ON THE ROSTER SUBMITTED TO CRPA.**
- Caravan trips may be booked before September 3, 2021. To avoid disappointment due to an unusual situation, towns are urged to call ahead to confirm days and hours for your visit.
- **No refunds will be given once rosters have been submitted to Six Flags.**
- Parking is an **ADDITIONAL FEE** payable directly to the park and must be purchased prior to arrival.
- Dining is available onsite or picnics are welcome.
