# Ticket Order Quantities:

- 1. Towns/Departments who are new to this program can start off with a 25 ticket starter packet.
- Towns that are returning for the 2021 season: ticket request cannot exceed 25 tickets <u>more</u> than sold in the previous year. Contact the CRPA office for your previous year total at (860) 721-0384.
  \*When you are down to your final 5 tickets we will gladly send you another 25 tickets.

## The Parks and Recreation Agency agrees to:

- 1. Return all unused tickets by <u>September 3, 2021</u> or accept full responsibility for payment of unused tickets.
- 2. Sell tickets only as part of a parks and recreation program, keeping written records.
- 3. Tickets cannot be refunded once redeemed at the park.
- 4. Adhere to all policies and rules which Six Flags has promulgated for safe operation of the Park. Some rides are restricted by height and size. No person shall bring alcoholic beverages into the Park. No outside catering service or bulk food and beverage may be brought into the Park. No picnic baskets or coolers will be permitted inside the Park
- 5. Be responsible for the accuracy of the ticket numbers and quantity delivered to you. Any discrepancies must be reported to CRPA upon receipt of your tickets. If nothing is communicated to CRPA, our office will assume that the order was accurate and the details on this form match the tickets delivered. CRPA cannot be held responsible for lost or missing, or wrongly-issued tickets if discrepancies are not reported to us within 24 hours of receiving the tickets.

## CRPA will provide:

- 1. Promotional materials, including posters and background information on Six Flags. (if requested)
- 2. Ticket delivery in a timely manner.
- 3. Telephone support to assist with your orders and planning needs.

### Important Information & Notices:

- Ticket sales may begin as soon as you receive tickets. All unsold tickets must be returned to CRPA by September 3, 2021. THIS IS A FIRM DATE. No tickets will be accepted after that date, and no refunds will be issued for any tickets returned after that date. <u>All tickets must be PAID IN FULL by September 3, 2021.</u>
- Although these tickets apply to all normal days and hours of operation for Six Flags, to avoid disappointment due to weather or an unusual situation, <u>you and your customers are urged to call ahead to confirm days and hours</u> <u>for your visit</u>. No refunds will be given once tickets have been redeemed. <u>Unused</u> tickets must be returned to CRPA no later than September 3, 2021 for a refund.
- 3. Please encourage all individuals purchasing tickets to check the schedule on Six Flag's website to confirm they are open the dates/times they wish to visit the park
- 4. Parking is an additional fee payable to Six Flags and must be purchased prior to arrival. Fee is subject to change.
- 5. Masks are optional, but encouraged, for unvaccinated visitors.
- 6. Cash is not accepted at the park. Only cards and mobile payments are accepted at all locations in the park including restaurants, retail stores, and games. Cash can be converted to a prepaid Visa debit card at one of the kiosks located through the park for no additional fee. Any remaining funds on the card can be used outside the park anywhere Visa cards are accepted.
