### About the Speakers:

**Deborah Lake** is the Director of Program Planning and Implementation at The Governor's Prevention Partnership. She has spent over five years working statewide with caring adults to educate them on substance use prevention interventions and working with local and state government agencies to support prevention work. **Wendy Mill** is the Program Coordinator for the Youth Advisory Council at The Governor's Prevention Partnership. Prior to working on state-level youth prevention projects, Wendy successfully worked with her town's local prevention council with multiple local collaborations. **Josh Freeman** is the Opioid Prevention Program Manager at The Partnerships, focusing on a project in New London County, he works with local organizations to provide opioid prevention education to parent organizations, town councils, and youth groups. **Anna Park** is a Recreation Supervisor for the Glastonbury Parks and Recreation Department and has been in her role for 23 years. In 2001 she collaborated with GLAD, the Town's Substance Abuse Prevention Coalition – now called GCAP, and received a Drug Free Communities Grant. The 10 year grant funded the creation of a Teen Center and a part-time Substance Abuse Prevention Coordinator in addition to many other projects and programs related to combatting substance issues in Glastonbury. Anna currently oversees the Teen Center and works collaboratively with GCAP and the Substance Abuse Prevention Coordinator on substance abuse prevention initiatives. **Sarah Toomey** is the Community Outreach & Recovery Navigator at Greenwood's Counseling Referrals, Inc.
