# 2026 CPSI COURSE INFORMATION

## BLENDLED LEARNING COURSE/EXAM INFORMATION:

### CPSI ONLINE PREP COURSE & VIRTUAL LEARNING SESSION:

- Following registration, course participants will receive an email with information on how to access the course.
- The Online Prep Course is an 8-modular course that is self-paced and approximately 12 hours in length. It is **HIGHLY ENCOURAGED** that you complete the online prep course at least 24 hours prior to the Virtual Learning Session.
- The Virtual Learning Session is a one-day, 4-hour virtual training course done via Zoom and led by a CPSI Instructor.
- This course has been approved for **1.5 CEU Credits** (*CEU fee is included in registration fee*). Participants must complete **BOTH** the CPSI Online Learning course and the CPSI Virtual Learning Session to receive CEUs.

### CPSI EXAM:

- Participants that are registered for the CPSI blended learning exam will be taking the exam at a local computer testing center and **MUST** register for the exam themselves, CRPA does not register you for the exam. (*instructions provided in exam candidate email*).

- Participants will receive an email with information on scheduling the exam approximately one week prior to the Live Virtual Course.

### TIMEFRAME:

- Course participants have **180 days** from registration date to access and complete the 12-hour online prep course.
- Course participants must complete the **4-hour Zoom** instructional meeting.
- Course participants will have approximately **83 days** following the Zoom meeting to take the computer-based exam.

## IN-PERSON COURSE/EXAM INFORMATION:

### SCHEDULE:

- Tuesday: Registration 7:30 - 8:00 am; Class 8:00 am - 5:00 pm.
- Wednesday: Class 8:00 am - 5:00 pm.
- Thursday: **Exam Check in: 8:00 am. Exam begins as soon as everyone is checked in.** Examinees have two hours to take the exam. **NEW - Only one (1) form of identification is needed.** To gain admission to the examination, a candidate needs to present one form of identification. ID must be a valid Government-issued ID with photo and signature. The information provided on the certification application must match the candidate's name on the identification. The candidate will also be required to sign a roster for verification of identity. Please bring sharpened #2 pencils.)

### GENERAL INFORMATION:

- Lunches will be provided Tuesday & Wednesday only. (please contact the CRPA office if dietary restrictions apply)
- Parking: Free parking is available onsite - please carpool if multiple people coming from same department
- No walk-ins will be allowed for the course or the exam.
- This course has been approved for **1.5 CEU Credits** (*CEU fee is included in registration fee*).
- Participants may register for the in-person course and elect to switch to Computer-Based Testing. To obtain additional information, please visit [www.nrpa.org](http://www.nrpa.org) under CERTIFICATIONS: CPSI. If you register to take the in-person exam and decide to switch to Computer-Based Testing, you will not receive a refund if you do not cancel by the date outlined in the cancellation policy. Course participants will have 90 days from the in-person course date to sit for the exam using Computer-Based Testing.

## **\*\*NEW\*\*** IN-PERSON COURSE & BLENDLED LEARNING COURSE CEU INFORMATION:

CPSI Certifications can now be renewed through CEU's! Certified professionals need to take 20 hours of professional development which is equivalent to 2 full CEU's (0.1 CEUs = 1 hour) over a 3 year renewal cycle. The 20 hours must include 10 hours (1 full CEU) from Group A and 10 hours (1 full CEU) from Group B content. Group A = Hazard ID, Risk Management & Group B = Surfacing, Playground Environment, Audit, Inspection & Maintenance. The CPSI Course (no exam needed) is worth 1.5 CEU's in total: .8 CEUs in Group A & .7 CEUs for Group B. Recertification via CEUs includes an application directly through NRPA with a fee of \$95 per member & \$125 for non-members. Participants are required to maintain and track their own CEU's and are subject to audit by NRPA.

## IMPORTANT NOTES:

- **COURSE-ONLY REGISTRANTS** will only participate in the course. You will not sign up or sit for the exam.
- **EXAM-ONLY REGISTRANTS** will only take the exam. You will not receive course materials or course information.
- You will receive the course study materials approximately three weeks before the course.
- NRPA does not recommend that you take the exam unless you have access to the materials three weeks prior to the course.
- If you register less than three weeks before the course date, you will need to pick up your study materials at the CRPA office or make other arrangements.
- Please access the [CPSI Candidate Handbook \(Paper & Pencil Testing\)](#) to review critical information regarding completing the course/examination. The handbook contains detailed information on requesting Special Accommodations, English as a Second Language accommodations, how to access Latin-American Spanish materials and day-of examination policies (wearable technology policy, ID policy, etc.)
- Once a participant has started the online learning course and/or opened the wrapping on their books, no refunds will be issued for course.
- Registration is on a first-paid, first-served basis.
- A minimum of 20 participants is required to run the blended learning class. A minimum of 25 participants is required to run the in-person course. Notification of class cancellation, if needed, will be two weeks prior to the start of the course.
